This form is used to assist the Commission on Accreditation in the evaluation of the program's compliance with the accreditation standard below:

**4.0.3**: The program uses Form AS 4(B) and/or Form AS 4(M) to report its most recent assessment outcomes for each program option to constituents and the public on its website and routinely up-dates (minimally every 2 years) its findings.

All programs accredited by the Council on Social Work Education's (CSWE) Commission on Accreditation (COA) are required to measure and report student learning outcomes. All students are assessed using a minimum of two measures on their mastery of the nine competencies that comprise the Educational Policy and Accreditation Standards (EPAS) and any additional competencies programs may choose to add. These holistic competencies reflect the dimensions (knowledge, values, skills, and cognitive & affective processes) of social work practice that all social workers are expected to master during their professional training.

Programs determine a percentage-based benchmark for each competency and determine an outcome-measure benchmark (minimum score) for each measure. The competency benchmark (which can differ for each competency) represents the minimum percent of students the program expects to have achieved the outcome measure benchmarks in both/all measures for each of the nine competencies. The program then determines the percentage of students that attained each outcome measure (e.g., minimum score or higher), and aggregates the percentages for both/all measures together to obtain the percentage of students demonstrating competence inclusive of two (2) or more measures. The result of aggregating both/all outcome measure percentages provides the percentage of students achieving the competency benchmark. An aggregated percentage at or above the competency benchmark is considered achievement of that competency. If the program has more than one program option, the program must report data for each program option, and also an aggregate of all program options combined to determine an overall percentage of students across all program options achieving the competency benchmark.

### **Assessment Data Collected during the Academic Year (2019-2020)**

\*Data reported are from the Field Educator's Assessment of Student Competency in SW 577 (Generalist) and SW 689 Field Education IV (Specialized practice) ALONE. We were unable to collect embedded assignment competency data this year due to shift from 2008 to 2015 EPAS, coupled with a transition to a new data monitoring system, coupled with COVID delaying such a transition. Additionally, this year we established a new benchmark: 75% at 3.5 on a 5.0 Likert scale.

The rating rubric includes: (5) Exemplary Competence: The student demonstrated exemplary competence of the practice behavior; (4): The student demonstrated advanced competence of the practice behavior; Competence (3): The student demonstrates competence of the practice behavior; Developing Competence (2): The student demonstrates developing competence of practice behavior.

Benchmark scores are presented for the percentage of students who have met competency (3.5 on a 5.0 Likert scale) among the 9 social work competencies. MSW program percentages have exceeded the identified benchmark in only one (1) competency: *Demonstrate Ethical and Professional Behavior*. Please note: These results must be considered within the context described above and no conclusions can be made at this time with the data as presented.
