## INTRODUCTION

Barry University recognizes that college level learning can take place outside of the traditional college classroom setting. Students in applicable degree programs can earn up to 90 credits toward the 120 (48 of which must be upper level) required for graduation through the assessment of prior learning as well as through transfer credit from a regionally accredited college or university.

Regardless of the number of transfer and/or prior learning credits accepted, all students must still complete Barry University's thirty credit residency requirement and the specific requirements of their degree program.

This fact book provides a detailed explanation of the assessment of prior learning options. The four major categories are: (1) the portfolio, (2) testing, (3) licensure/certification, and 4) non-traditional transfer credit.

**THE PORTFOLIO:** The portfolio is the vehicle through which students can demonstrate college level learning in order to receive credit for learning from professional work experience and/or community service in one or more of the following competencies: administration, communication, creativity, critical thinking, interpersonal relations, investigation and research, leadership and supervision. Specific guidelines for developing a portfolio are given in the portfolio online submission program in Canvas. Students' academic advisors guide them through the process and determine when their portfolio is ready for submission to faculty evaluators.

**TESTING:** Testing includes examinations of the Educational Testing Service, including the College Level Examination Program (CLEP), the Advanced Placement program (AP), the Defense Activity for Nontraditional Education Support (DANTES), and Barry University Challenge Exams.

**LICENSURE/CERTIFICATION:** Licensure/certification is the awarding of transfer credits to students who hold licenses or certificates recognized by Barry University. Credit is awarded for the license(s)/certificate(s) itself or for courses completed at federal and state institutions leading to issuance of the license(s)/certificate(s). **All license credits appear as General Electives on students' transcripts. Additionally, licensure credits will be processed as unofficial evaluations, and will not be entered into the system until payment has been made. The unofficial evaluation will include a statement such as "Licensure credit will be applied to the student's record upon payment of fee stated on the application".** The bill that is sent to the student (copy to advisor and to Student Accounts) will state that "payment must be received by the end of the current semester" at which time the licensure application will be voided if payment has not been received,

**NONTRADITIONAL TRANSFER CREDIT:** Nontraditional transfer credit includes the American Council on Education's College Credit Recommendation Service (CREDIT) which includes credit recommendations for courses or examinations offered by various organizations and the military and course work recommended for credit by the National College Credit Recommendation Service (CCRS) formerly National Program on Non-Collegiate Sponsored Instruction (PONSI).

**THE PORTFOLIO**

**INTRODUCTION**

The portfolio is the mechanism for translating college level learning acquired through professional work experiences and/or community activities into Barry University credit. The portfolio is an option for students pursuing the Bachelor of Science degree in Emergency Management, the Bachelor of Science degree in Organizational Leadership, and the Bachelor of Science degree in Public Administration. The portfolio format and content are fully explained online in Canvas. Your academic advisor will register you in the Portfolio Online Submission Program and guide you through the development process. Please review the Experiential Learning portfolio orientation as well.

**CATEGORY:** Portfolio.

**TYPE OF CREDIT AWARDED:**

Upper/lower-level credit in electives and for some degree requirements. Check the Barry University Student Bulletin for further information.

**MAXIMUM ALLOWABLE CREDIT:**

Students can earn up to thirty (30) credits from the portfolio either in transfer and/or gained through the Barry University portfolio program. One-third to one-half of these credits may be designated upper level.

**CONDITIONS:**

Students must be fully admitted to Barry at the time of submission of the portfolio, have completed English 302 or English 112 with a grade of at least C, or have demonstrated proficiency on the English exam, have a cumulative grade point average of 2.0, and be able to document at least five years of full-time work experience and/or community service. The portfolio must be submitted at least one semester prior to degree completion. Students are required to have 90 credits or less at submission.

**DOCUMENTATION:**

Documentation for the portfolio includes original letters on letterhead stationery signed by employers confirming student's job responsibilities and abilities, copies of certificates from in-service courses, and of awards/honors, and verification of active participation in professional and community organizations.

**FEE:**

There is a fixed administrative fee for the portfolio of \$1950.

**COLLEGE LEVEL EXAMINATION  
PROGRAM (CLEP)**

**DESCRIPTION**

CLEP is the College Level Examination Program developed by the College Board and administered by the Educational Testing Service (ETS). It allows students to obtain credit for college level achievement gained outside of the classroom. See Exhibit I for a complete list of CLEP examinations (discontinued and current) along with the minimum score required to receive college credit. For general information on CLEP and the location of CLEP testing sites please go to <http://clep.collegeboard.org> or call 1 800 257-9558.

**CATEGORY:** Testing/transfer.

**TYPE OF CREDIT AWARDED:**

Lower level elective or distribution credit.

**MAXIMUM ALLOWABLE CREDIT:**

A maximum of thirty (30) credits can be earned from all testing/transfer sources.

**CONDITIONS:**

All CLEP credits must be earned prior to achieving junior status (60 credit hours). Care is recommended to avoid overlap between General and Subject Examinations and between CLEP and earned college credit. Credit will not be awarded in cases of duplication, nor will equivalencies be changed to remedy such duplication. CLEP will not supersede earned college credit. The maximum CLEP credits in any one discipline may not exceed six. All CLEP credit is accepted on a credit/no credit basis.

**DOCUMENTATION:**

CLEP score reports must be sent directly to Barry from the Educational Testing Service. Transcripts can be obtained from:

**FEE:**

There is a charge for each CLEP exam payable at the test site and a fee for the test transcript. In addition, Barry University charges an administrative fee for processing CLEP credits at \$100 per credit.

### EXHIBIT 1

## COLLEGE LEVEL EXAMINATION PROGRAM (CLEP)

All CLEP credits must be earned prior to a student achieving junior status (60 credit hours). For new students, the award of CLEP credit is made by the Office of Admissions; for enrolled students, the award of credit is processed through the Office of the Registrar. All CLEP credit is accepted on a credit/no credit basis. A maximum of 30 credits will be accepted through CLEP. Barry University will accept a total of 30 credits from all testing programs.

Care is recommended to avoid overlap between CLEP and earned college credit. Credit will not be awarded in cases of duplication, nor will equivalencies be changed to remedy such duplication. CLEP credit will not supersede earned college credit.

CLEP credits in any one discipline may not exceed six. All credits awarded as electives will be considered lower level. Barry University will accept CLEP credit as outlined below:

**ADVANCED PLACEMENT**  
**(AP)**

**DESCRIPTION:**

AP is the Advanced Placement program of the College Board, which provides for the establishment of college level courses completed in secondary schools. Students who take such a course or courses may then take special examinations prepared by the College Entrance Examination Board. Credits are accepted on a credit/no credit basis. See Exhibit II for a listing of AP examinations and credit awards.

**CATEGORY:** Testing/transfer.

**TYPE OF CREDIT AWARDED:**

Lower level elective or distribution credits.

**MAXIMUM ALLOWABLE CREDIT:**

A maximum of thirty (30) credits can be earned from all testing/transfer sources.

**CONDITIONS:**

Credit for Advanced Placement examination is based on the one year AP experience. Credit is given only in cases of scores of 3 or better on the exam with the exception of the French and Spanish language exams where a score of 4 is required to receive credit. Credit varies from 3 to 8 semester hours, depending on equivalencies available at Barry University. In no case will credit be given for more than one year's work. Advanced Placement credit cannot be duplicated either in regular courses or through the CLEP program.

## Credit by Examination Policies **EXHIBIT 2**

### ADVANCED PLACEMENT (AP)

The Advanced Placement Program, a program sponsored by the College Board, provides for the establishment of college-level courses in secondary schools. Students who take such a course or courses may then take special examinations prepared by the College Board. Credit for Advanced Placement examinations is based on the one-year AP experience. Credit is given only in cases of scores of 3 or better. Credit varies from 3 to 8 semester hours, depending on equivalencies available at Barry University. In no case will credit be given for more than one year's work. Advanced Placement credit cannot be duplicated either in regular courses or through the College Level Examination Program. A maximum of 30 credits will be accepted through the Advanced Placement Program. Credits are accepted on a credit/no credit basis. Barry University will accept a total of 30 credits from all testing programs. All credits awarded as electives will be considered lower level. Barry University will accept AP credit as outlined below:

**DEFENSE ACTIVITY FOR NONTRADITIONAL EDUCATION SUPPORT**  
**(DANTES/DSST)**

**DESCRIPTION:**

DSST (DANTES Subject Standardized Tests) is an acronym for the Defense Activity for Nontraditional Education Support. DANTES examinations enable students to obtain college credit for what they learned on the job, through self-study, personal interest, correspondence courses, or any other means. There are 38 DANTES Subject Standardized Tests covering a wide range of college-level academic, business, and technical subjects. The exams are offered at area colleges and universities. For each test there is a Fact Sheet/Study Guide containing a description of the test content, sample questions, and a list of texts appropriate for review. Fact Sheets can be downloaded from [www.getcollegecredit.com](http://www.getcollegecredit.com). See Exhibit III for a listing of DANTES subject standardized tests.

**CATEGORY:** Testing/transfer.

**TYPE OF CREDIT AWARDED:**

Upper or lower level elective or distribution credits to be determined by the Office of Transcript Evaluation.

**MAXIMUM ALLOWABLE CREDIT:**

A maximum of thirty (30) credits can be earned from DANTES exams of which only 6 can be upper level..A maximum of thirty credits can be earned from all testing/transfer sources.

**CONDITIONS:**

All DANTES credits must be earned prior to achieving junior status (60 credit hours).

**DOCUMENTATION:**

**UNIVERSITY CHALLENGE EXAMS**

**DESCRIPTION:**

Challenge exams are university constructed tests which allow students to demonstrate previously acquired knowledge of a course(s) offered at Barry University and earn credit for it. Currently CS 180 (Introduction to Digital Literacy), IT 190 (Microcomputer Basics) and IT 200\* (Foundations of Information Technology) are available to students. Students may obtain information on signing up to take an examination by contacting their advisor. Each successfully completed examination is worth three credits and letter grades are not assigned. Exhibit IV contains study outlines for each exam.

**CATEGORY:** Testing/transfer.

**TYPE OF CREDIT AWARDED:**

Lower level elective credit.

**MAXIMUM ALLOWABLE CREDIT:**

At present students may earn nine (9) credits for testing out of CS 180, IT 190, and IT 200. A maximum of thirty (30) credits can be earned from all testing/transfer credit.

**CONDITIONS:**

Students who have already received credit for CS 180, IT 190, IT 200, or the equivalent are not eligible for the exam(s). \*Academic coordinator approval must be obtained prior to taking the IT 200 examination.

**DOCUMENTATION:**

Students receiving a passing score must submit proof of payment of appropriate fees to the Registrar's Office before earned credit can be awarded on the transcript.

**FEES:** There is a \$75 fee for each challenge exam payable prior to the examination.

## CS 180/IT 190/200 STUDY OUTLINES

### CS 180 – Introduction to Digital Literacy (3 Credits)

#### Overview:

The CS 180 test out exam consists of three sections. Students must score at least 75% in each section in order to pass the exam.

#### Exam Topics:

Students should be able to demonstrate proficiency in the following main concepts and computer application areas:

- Microsoft Word – Creating, editing, and formatting a document containing text and graphics.
- Microsoft Excel - Creating and modifying worksheets and charts.
- Microsoft PowerPoint - Creating and modifying interactive slides.
- World Wide Web – Using http, telnet, and ftp URL's & searching.
- Electronic Mail – Sending and receiving mail; attachments.
- Windows Operating System – Components of Windows, interacting with Windows, Basic skills in copying, moving, renaming, and deleting files; creating and navigating directories; organizing files in directories, computer peripherals, data and information storage and processing.
- Library Skills – performing electronic database searches

### IT 190 - Microcomputer Basics (3 credits)

#### Overview:

This exam consists of 60-100 multiple choice questions. To pass this exam, students need to score at least 75%. Their score will be displayed at the end of the exam. Students have **60-90 minutes** to complete the exam. Students may skip questions and return to them later as long as they do so within the allotted hour.

#### Exam Topics:

Students should be able to define terms, identify problems, and provide solutions in the following topic areas:

- Microcomputer hardware, including internal and peripheral components
- Internal and external system cables, connectors, ports and interfaces
- Windows operating systems (OS) tools and utilities
- How the OS works with hardware and software
- The boot processes
- Installing, supporting, and troubleshooting Windows
- Supporting hard drives
- Wired and wireless networking fundamentals and the Internet
- Mobile computing

### IT 200 - Foundations of Information Technology (3 Credits)

#### Overview:

This exam consists of 60-100 multiple choice questions. To pass this exam, students need to score at least 75%. The score will be displayed at the end of the exam. Students have **60-90 minutes** to complete the exam. Students may skip questions and return to them later as long as they do so within the allotted hour.

#### Exam Topics:

Students will be examined on the following general information technology topics:

- Applications and System Software
- Computer Hardware & Storage
- Input/ Output Operations and Devices
- Networks and Telecommunications, Computer Ethics
- E-commerce and Information Systems
- Files and Databases, Software development and programming languages

**LICENSURE/CERTIFICATION**

**DESCRIPTION:**

Licensure/certification is the awarding of college credit for one or more professional licenses, technical certifications, and/or the courses leading up to the license currently recognized and determined by Barry University. Competencies recognized for licenses may include administration, communication, creativity, critical thinking, interpersonal relations, investigation and research, supervision and leadership. **CATEGORY:** Licensure/transfer credit.

**TYPE OF CREDIT AWARDED.**

Upper/Level (UL) and Lower Level (LL) general elective credit.

**MAXIMUM ALLOWABLE CREDIT:**

Licensure credit is included in the maximum allowance of ninety (90) credits from all transfer sources.

**CONDITIONS:**

Students who no longer possess their original license (s/ certification(s)) will need to provide notarized verification of attainment of them from the specific licensing/certification agency. **If coursework was taken at a regionally accredited institution and applied toward attainment of the license, no further credit can be granted through licensure/certification.** Students may submit documentation for licensure credit anytime during their tenure at Barry. Comparable licenses/certifications from other states will be honored following verification of training.

**DOCUMENTATION:**

Students must submit a valid license(s)/certification(s) to their Advisor/Portfolio Director who will forward a copy to the Office of Admissions. Technical Certifications require an additional form that must be approved by the Assistant Dean of Information Technology before being sent to the Portfolio Director. Official transcripts of courses leading up to the license(s)/certification(s) must be submitted directly to the Office of Admissions.

**FEE:**

**TECHNICAL CERTIFICATION LICENSURES**

**DESCRIPTION:**

Technical Certification Licensure is the awarding of college credit for IT certifications that support current programs and curriculum offered through Barry University (BU). Learned competencies recognized for certification follow the guidelines of those awarded in student portfolios. Learned competencies are awarded in the content areas of Computer Applications, Information Technology, and Network and Systems Engineering. Upper-level credits reflect learned competencies of communication, critical thinking, and administration in the content area (see Exhibit V (a) for a listing of technical certification awards.

**CATEGORY:** Licensure/transfer Credit.

**TYPE OF CREDIT AWARDED:**

Upper-Level (UL) and Lower-Level (LL) elective credit.

**MAXIMUM ALLOWABLE CREDIT:**

Licensure credit is included in the maximum allowance of ninety (90) credits from all transfer sources. A maximum of 15 Credits can be obtained for any combination of Technical Certification Licensure.

**CONDITIONS:**

If coursework was taken at a regionally accredited institution for credit as specific preparation for the attainment of the technical certification, licensure credit will not be granted. Students may submit documentation for licensure credit anytime during their tenure at Barry.

\*BS-IT students wishing to transfer IT 310 and/or IT 320 into the major core must have submitted the licensure credit application within the first semester of being accepted into the BS-IT program (program not accepting new applications).

**DOCUMENTATION AND PROCESS:**

Students and advisors must complete the ASSESSMENT OF PRIOR LEARNING FOR TECHNICAL CERTIFICATION LICENSURE CREDIT APPLICATION and provide original certificates, wallet cards, and/or vendor transcripts of certifications earned to their advisor who will make copies and forward along with the completed application to the IT Certification Coordinator. Please note that a separate Licensure Credit Application Form must also be attached for each certification.

**FEE:**

Barry University charges an administrative fee for processing licensure credit which is \$50 per credit awarded (see fee schedule/Appendix C).

## **APPENDIX B A CASE STUDY**

### **The Case of Mike T. Duck**

The Mighty Duck, as he is known by his friends, is a young man on the move. It was not always that way. When he graduated from high school, the future was not bright. Finances necessitated he deviate from the preferred route of a full-time college man and sign on with Florida Power and Light (FP & L) while attending classes at night. Mike has been quite a standout at FPL, and as a part-time student at Florida International University (FIU), has accumulated a total of 65 credits. Pleased with his progress and promotions on the job, Mike was also content with the progress toward his degree. Now, however, he has reached a point in the company where the next promotion not only requires a strong work history but a bachelor's degree as well.

Mike heard of Barry University's Adult Learner degree programs through a friend at work and decided it might well be the route to go as FIU classes are predominantly in the daytime, and the traditional semesters will not allow him to complete a degree within the necessary timeframe. The big question now, as with all students, is what kind of timeframe are we talking about?

The FIU credits will all count toward his degree as they are from a regionally accredited university, and all grades are C or better. Some credits may count toward his major, some in the distribution and the rest as electives, all toward the minimum of 120 credits needed to graduate. Mike never took AP classes in high school and has earned more than 60 college credits so is ineligible for CLEP. What he can do testing-wise is take the CS 180 challenge exam to meet the computer proficiency requirement since he is somewhat of a computer wizard. This exam will save him time and money. It is possible then for Mike to transfer in a considerable number of credits, complete 10 courses, and submit a portfolio for the remaining credits toward his bachelor's degree.

At Barry, Mike's advisor suggests he pursue the Bachelor of Science in Administration degree to earn a degree that will help him achieve his career goals. The advisor's rationale is that Mike, like every student, needs to satisfy Barry's 30-credit residency requirement. The Admissions Office's evaluation of Mike's transfer credits shows that within these required 30 credits of coursework, he can both complete deficiencies in the mandatory 45 credit distribution courses as well as the 30 credits needed for his major as six of his FIU credits can be used for the latter.
