



The program is currently facing barriers primarily shaped by the political climate and the resulting financial constraints students face. Shifts in federal and state funding priorities, along with uncertainty surrounding financial aid, loan forgiveness programs, and mental health workforce investments, have increased the financial burden on students pursuing counseling degrees. Rising tuition, cost-of-living expenses, and unpaid or underpaid practicum and internship requirements create significant access and retention challenges, particularly for students from historically marginalized or economically disadvantaged backgrounds. Additionally, political discourse and legislative actions affecting higher education and mental health professions contribute to student uncertainty about career stability, licensure portability, and long-term professional viability. These factors collectively affect enrollment decisions, persistence in the program, and students' ability to fully engage in their training, underscoring the need for increased advocacy, financial support mechanisms, and institutional responsiveness in the current political environment.

Q93. What successes or available resources have contributed most to your program's growth, effectiveness, or ability to support students?

The program's growth, effectiveness, and strong student support are largely attributable to its stable institutional foundation, sustained CACREP accreditation, and a well-established infrastructure aligned with professional counseling standards. Consistent administrative and financial support from the institution has enabled the program to maintain qualified core faculty, manageable faculty-to-student ratios, and ongoing professional development, all of which contribute to instructional quality and mentorship. Long-standing partnerships with community agencies and school systems provide reliable, high-quality practicum and internship placements, supporting students' clinical development and successful transition into the profession. Additionally, comprehensive student support resources—including academic advising, licensure preparation, technology access, and wellness services—enhance student retention and success. The program's commitment to continuous assessment, data-informed decision-making, and alignment with CACREP standards ensures responsiveness to student needs and evolving professional expectations, thereby sustaining program effectiveness and long-term stability.

Our program's growth, effectiveness, and ability to support students have been strongly supported by the structure and guidance provided through CACREP accreditation. CACREP's precise and comprehensive standards offer a stable framework for curriculum design, faculty qualifications, and clinical training, which promotes consistency, rigor, and alignment with professional expectations. The accreditation process has strengthened our program's continuous improvement efforts by encouraging regular assessment of student learning outcomes, program effectiveness, and stakeholder feedback without being punitive. We particularly appreciate CACREP's emphasis on professional identity development, ethical practice, and clinical competency, which helps ensure our graduates are well prepared for licensure and practice across settings. CACREP's resources, training, and accreditation support materials have been valuable in assisting faculty to remain informed about evolving standards and best practices, while fostering collaboration and shared understanding across counseling programs nationally. Overall, CACREP's approach supports program stability, student success, and accountability in ways that enhance, rather than hinder, our ability to serve students and meet workforce needs.

Q99. What would you like to see CACREP do differently in its current services?

We would appreciate it if CACREP could increase flexibility in standards implementation to better accommodate the diverse contexts of institutions and the varied needs of student populations. Expanding advocacy efforts at both state and federal levels, particularly regarding counselor licensure portability, beyond the Counseling Compact, and broader workforce needs, would further support programs and graduates. Additional resources or guidance to address financial barriers faced by students, especially those related to unpaid clinical training, would help ensure equitable access and student success. Finally, enhancing communication and technical assistance for programs navigating accreditation updates or transitions would strengthen program support and facilitate smoother compliance with evolving standards.

We recommend that CACREP consider increasing flexibility in how accreditation standards are applied to better accommodate the diversity of institutional contexts and student populations. Expanding advocacy efforts at the state and federal levels, particularly around counselor licensure portability and workforce development, would further support programs and graduates. Additionally, developing resources or guidance to address financial barriers faced by students, especially those related to unpaid clinical training, would enhance equitable access and student success. Strengthening communication and providing more proactive technical assistance during accreditation updates, transitions, and standards revisions would help programs navigate requirements efficiently and maintain compliance, ultimately supporting program effectiveness and the continued preparation of competent, ethical counseling professionals.
